Polytechnic College, Palakkad an education institution, incorporated under the provisions of Department of Technical Education, Govt. of Kerala having its registered office at "Trivandrum" (hereinafter referred to as the "Second Party", which expression shall, unless repugnant to the meaning or context thereof, be deemed to include all permitted successors and assigns) of the **SECOND PART**.

**WHEREIN**, the party of the first part shall be individually referred to as "first party", and the party of the second part shall be individually referred to as "second party", as the context may require, and the first party and the second party shall be collectively referred to as "parties" and severally as "party".
